As you are walking through your priorities, make notes if any of the following “flags” stand out. Note the related priority/objective/strategy #, if applicable.

-  Content Flags: What’s missing? What needs to be modified?
-  Criticality Flags: What’s critical? What is most important to begin immediately?
-  Coordination Flags: What partnerships or linkages currently exist or need to be formed?
-  Collection, Compilation, and Communication Flags: What data or information needs to be collected, compiled, or better communicated?
-  Capital and Capacity Flags: What resources or infrastructure exist or is needed?
-  Cross-cutting, CYSHCN Flags: What do we need to note or be particularly mindful of related to cross-cutting/lifecourse OR special health care needs domain areas?
