Commission Recommendations for MCH

MCH. 1 Legislative

Expand Medicaid

MCH. 2 State or Agency, Legislative

Offer comprehensive maternal benefits though Medicaid

Such as: Home visiting, clinical training on health equity and implicit bias, broader network for maternity care providers in rural areas and potential benefits for doula care

MCH Alignment or Support

The MCH team partner with Medicaid staff to share identified gaps and barriers in benefits for the MCH populations based on what families and local partners are telling us.

Work with Medicaid on policy development and disseminate information with the public and partners (unwinding).

Expanded Universal Home visiting.

Becoming a Mom training for local partners.

Third Thursday webinar, ECHO's and other training targeting a variety of providers across the state using an equity lens.



Commission Recommendations for MCH

MCH. 3 State or Agency, Legislative

Extend Medicaid coverage for mothers to 12 months postpartum

MCH. 4 State or Agency

Publicly report measures of child health by race and ethnicity and service location (region, plan, provider), starting with the developmental screening measure for children ages 0-3.

MCH Alignment or Support

With input from the MCH team about the need for expanded postpartum care Medicaid extending coverage for continuous 12-month post-partum care.

Much of this data is currently collected through the MCH data systems. MCH has also increased funding for the Child Health Survey data to identify more of this information including special health care needs data. The team regularly reviews data to inform program decision making.



Commission Recommendations for MCH

MCH. 5 State or Agency

Develop payment policy to support the health if the child and caregiver relationship, using a model of "two-generation" care.

Infant-childhood mental health; family therapy, parenting programs; medical homes; and comprehensive home visiting

MCH. 6 State or Agency

Use quality programs as part of Managed Care Organization contracts to improve quality of care.

Commission Recommendations for MCH

MCH. 7 State or Agency, Local

Train partners to use a birth equity framework

MCH. 8 State or Agency, Local

Establish First 1000 day "health home" for new moths and children ages 0-3

MCH. 9 State or Agency

Develop payment policies to reimburse community –based providers such as Community Health Workers, home visiting, doulas and lactation consultants.

MCH Alignment or Support

The KS-SHCN program provides families from birth to age 21 with holistic care coordination services and supports

Referral process in place between KS-SHCN program and Newborn Screening Programs.

Universal Home Visiting

MCH team worked with Medicaid to help support billing for CHWs.

Postpartum screening tools are used by local partners

Commission Recommendations for MCH

MCH Alignment or Support

MCH. 10 Legislative

Improve health of children by reducing the number of uninsured children through enabling continuous coverage for children ages 0-5

MCH. 11 Legislative

Raise income level for the Children's Health Insurance Program (CHIP) and Pregnant women to 240% of the Federal Poverty Level (FPL) The MCH team helped support the unwinding efforts.

Continued promotion of the importance of a well-child check, developmental screenings and encouragement and assistance to apply for Medicaid.



Commission Recommendations for MCH

MCH. 12 State or Agency, Legislative

Support telehealth policies to improve maternal and child health outcomes and maintain access to telehealth services post COVID-19

MCH. 13 State or Agency, Local

Partner with state groups to offer best practices and education for mothers and families during and after Pregnancy

MCH Alignment or Support

KS-SHCN conducted a survey with families on the waiver programs to determine how policies changes during the Public Health Emergency (PHE) effected their child and family. This has led to some policies being extended beyond the PHE such as telehealth.

The MCH team supports with local health agencies in the use of evidence-based or best practices for prenatal, postpartum and parenting programs such as Becoming a Mom and through the Kansas Perinatal Community Collaboratives.
